Grab your phone and the inverter's QR code--the one that looks like a chaotic checkerboard. Wait, no... Actually, it's the second QR code below the serial number. See how easy it is to mix them up?

The Moment of Truth

1. Log into Growatt's portal
2. Click "Add Device"
3. Scan QR code or manually enter SPHxxxx number
4. Verify system time zone (this step trips up 40% of users!)

When the "Invalid Plant" error pops up (and it will for 1 in 3 users), don't panic. Try our patented 3-2-1 fix:

Force-quit the Growatt app

Clear cache under Settings > Storage

Reinstall using APK version 4.2.6 (new builds have WiFi bugs)
