How long do energy storage projects last in New York? Projects procured in the RFP may have a maximum term of 15 years and must be operational by 31 December . In June , New York governor Kathy Hochul approved the Energy Storage Roadmap 2.0, which includes a statewide goal of deploying 6GW of energy storage on the NYISO grid by . What types of energy storage projects are eligible? Projects must be new, permanent, and stationary. Commercially-available chemical, thermal, and mechanical technologies are eligible, and energy storage projects may be either located behind a customer's electric meter, or interconnected directly to the distribution network. What is a residential energy storage incentive? Storage systems may be standalone, or paired with a new or existing clean on-site generation like solar, fuel cells, or combined heat and power. The Residential Energy Storage Incentive is available for New York State residents installing grid-connected energy storage on a new or existing home. What is NYSERDA's bulk energy storage program? NYSERDA's Bulk Energy Storage Program employs a novel Index Storage Credit (ISC) incentive, as established in the New York Public Service Commission (PSC) Order, modeled in part after the Renewable Energy Certificate (REC) and Offshore Wind Renewable Energy Credit (OREC) utilized in other NYSERDA programs. What energy storage incentives are available in New York State? The Residential Energy Storage Incentive is available for New York State residents installing grid-connected energy storage on a new or existing home. Incentives are available for up to 25 kWh of storage capacity. The Retail Energy Storage Incentive is available for projects up to 5 megawatts (MW). Projects must be new, permanent, and stationary. Are energy storage projects required to meet new fire safety codes? Any NYSERDA-supported energy storage projects are contractually required to meet the new storage safety codes adopted last week into Uniform Code by the State Fire Prevention and Building Code Council, which reflect the work and recommendations from the New York State Inter-Agency Fire Safety Working Group (FSWG).
